Products.

(a) Bitcoin Mining Hashpower Packages

(c) ICOs / STOs

NEXUS Global Factoring Limited is offering to its distributors a variety of Initial Coin Offerings and/or Security Token Offerings. Those ICOs/STOs are carefully selected and proven by the NEXUS Global advisory board and legal team. Most of those ICOs are reverse ICOs, which means that the companies offering the ICOs have a proven track record. Furthermore those ICOs and STOs are part of the NEXUS Global Unilevel Plan. NEXUS Global can not give any guarantees for the money invested by distributors and/or possible clients. NEXUS Global Factoring highly recommends only to invest the amount of money that you can effort, even if ICOs/STOs have a high potential of earnings sometimes.
